## From the HOA President:

Delinquent accounts have declined significantly in the last year, Treasurer Markus Albrecht reported at the Oct. 16 Silverlakes HOA Board of Directors meeting. At the end of July last year, the balance of delinquent accounts stood at \$72,842, compared to \$12,834 today.

This was accomplished through the efforts of our treasurer, with help from our secretary, Jim Wisniewski. Thanks to both for a great job. Keep up the good work!

We have been operating well under budget, so with the surplus cash, we are replacing all the pool furniture. We will offer half of the existing pool lounges, chairs and tables for sale at the rescheduled Oct. 26 community garage sale. The new furniture will not have plastic straps but will feature "sling" material that will look a lot nicer. The expected delivery date for the new furniture is sometime in the middle of November.

Concerns were expressed at the meeting by both a Silverlakes resident and a board member about proposed blasting in the construction area of Lennar's new Timber Creek community.
