### In memoriam

Silverlakes lost two long-time residents since the last newsletter was published.

- Jim Steiner, 77, passed away Dec. 28 at home surrounded by his loving family. He and his wife of 55 years, Marilyn, moved to Silverlakes in 1996 from Long Island, N.Y., following their retirement. In addition to Marilyn, Jim is survived by his children, Jason and Justine, and three grandchildren. Jim was a proud veteran of the U.S. Air Force, having served from 1966 to 1970.
- Leo Weiner Jr., 97, purchased his home in Silverlakes in 1998. He passed away Jan. 31 in Eagle Ridge Health and Rehab Center. He was a firefighter for 30 years in Indianapolis, Ind., and worked as a bagger for 25 years at Publix at Lee Boulevard and Route 80 until his retirement. Leo served in two branches of the military and was the last of his family, having survived five siblings and a son.

# **COMMUNITY UPDATES**

All of the Silverlakes' recent community improvements are funded through our Reserve accounts. Some of the labor associated with these projects has been donated by our volunteer residents. Many thanks to those members of our community who help keep Silverlakes a beautiful place to live. Major recent projects include;

- Landscaping enhancements to the front entrance area.
- Installation of bollards to deter vehicles from entering the community through the exit gates
- Procurement of (2) new Air Conditioning Units in the clubhouse.
- An improved camera surveillance system.
- Purchase of a large screen TV and speaker system for clubhouse.
- Implementation of a more comprehensive and user-friendly calendar on the Silverlakes website.

# TREASURER UPDATE

### 2025 Operating Budget Approved

The 2025 Operating Budget was approved at the November 27, 2024 Board of Director's Meeting.

The annual budget of \$348,224 represents an increase of less than \$2,000 over the 2024 budget.

2025 budgeted expenses include increased costs for insurance and contracts which are offset by strong investment returns on reserve fund balances, application fees for prospective buyers, and cost savings resulting from our resident volunteers donating their time and talent to keep Silverlakes a beautiful community to live in.


As a result of continued fiscal controls, 2025 homeowner dues for single family homes will remain the same as 2024 at \$248 per quarter, while our villas owners experience a (10%) increase in their dues from \$591 to \$655.

The increase in villas dues results from rising landscaping costs for 2025.

HOA dues for single family homes have remained relatively flat for the eighth year in a row.

This has been achieved through the negotiation of competitive contracts, ensuring that reserve funds are earning competitive interest rates, and resident volunteers. During 2025, the Board anticipates completion of the following projects; purchase of new pool furniture, repair or replacement of front clubhouse doors and further landscaping for front entrance area.
