From the HOA

President:

In keeping with the Silverlakes-Gateway HOA Board of Directors' commitment to open and honest communication with the membership, I offer the following comments on the March 15 annual membership meeting.

In order to hold the meeting, 99 proxies had to be returned. Some of the attendees did not receive their second mailings, so they filled out their proxies upon entering, giving us 117.

An audit of our 2015 expenses was requested at the 2016 annual membership meeting. The audit was completed and paid for during the 2016 business year. In the auditors' opinion, Silverlakes 2015 accounts were represented fairly in all respects, and Silverlakes is in accordance with sound accounting principles. HOA and Villa reserves are in conformity, as well. The cost of the audit was \$4,000.

A homeowner asked if the total administration fees of \$112,751 in 2016 were all paid to Alliant Management. It was explained that Alliant's management fee is \$3,050 per month or \$36,600/year. The balance of the administration costs includes legal and professional fees, postage, bad debt allowance, office expenses, HOA administration, Silverlakes website, licenses, communications committee, social committee, interest on the clubhouse loan, software for the gate access and insurance for officers, property and workers' comp. It is required that we carry workers' comp, which costs \$531.97 per year.

Several people in attendance were upset that there had been no prior notification that the clubhouse and pool would be closed during the day while the roof is being replaced and that the facilities would not open until 7 p.m. The board explained that it had discussed the roofing project during the February board meeting and the unapproved minutes had been

posted to the website. The board wants the work completed prior to the beginning of the rainy season.

A special board meeting notice was posted 48 hours in advance, as required. During that meeting, the tile color selected was the most popular among voting residents. In addition, a contractor was selected and approved. It was suggested an e-blast be sent out when a special board is scheduled, not just posted on the clubhouse doors and bulletin board. This will be the case in the future. Also, the exercise room will be open daily from 5 to 7:30 a.m., prior to the arrival of the roofers, and when roofers are not present, people will be allowed to use the pool.

It was also mentioned there are dogs running loose. The board cannot do anything unless a letter is sent to the board indicating the address of the violator.

Jane Grethey did not seek re-election to the board, and PJ Stratton has agreed to continue serving. Jim Wisniewski submitted his resume for Jane's seat. It was asked if a snowbird could run for the board. That is permitted as long as he/she is a homeowner and is available in person for the majority of the regularly scheduled and special board meetings.

Jane Grethey was thanked for her service as board secretary during these past three years, as well as for contacting, contracting and working with a web developer on Silverlakes' new website. Jane has since volunteered to continue to help with our new website in an advisory capacity.

The results of the votes on our proxy questions:

- May the Association use reserve funds during the year to balance cash flow requirements in case of an emergency? (such as a hurricane) 113 YES, 4 NO
- Should a Review by a CPA firm be waived for the 2017 Association's financials and, instead, a report of cash receipts and disbursements be issued by the Management Company? (a review would cost \$3,000 to \$5,000) 87 YES, 30 NO

Other comments from the membership included a complaint about the illegal lease sign displayed in the lawn of a rental property across from the clubhouse. There have been calls made, messages left, as well as a violation letter sent. There has been no response. A second violation letter will be sent and, if there is no response, the fine process will start.

It was asked if we can put a maximum percentage requirement on the number of properties in Silverlakes that can be rented. That would be a substantial change to Silverlakes covenants, and so it would require a 75 percent "yes" vote of ALL 329 owners, not just 75 percent of proxies returned. Since only 117 proxies were returned for the annual meeting, it is highly unlikely the board would receive the 247 "yes" votes required to make the change.

It was further noted that our covenants state that a home may not be rented more than three times/year and for not less than 30 days at a time. All lease application forms must be sent to Alliant and approved by the board. Alliant will assess fines if rentals/leases exceed the maximum number allowed per year and/or if for less than 30 days. In addition, Alliant will assess fines if an owner does not follow the required lease application process. There are currently 29 rentals/leases in Silverlakes, or 9 percent of the total homes.

It was suggested the covenants be changed for future buyers to prohibit rentals/leases. As was stated earlier, this change would probably not receive the required "yes" votes to make this happen.

There was a complaint that the backyards of some rental homes that are not on the lakes are overgrown. It was alleged that renters don't care, and some absentee owners never visit the properties.

It was asked why only those homeowners who live on ponds are required to maintain their backyards. Just like the front of the homes, others can see those backyards from across the ponds. If a letter is sent to the board stating the address of an unmaintained home, the board will act.

A homeowner told the board that he had heard that one investment company owns 11 properties in Silverlakes. This may be true of another community in Gateway or Gateway itself, but there is only one company in Silverlakes that owns three properties, and that's the most owned by one firm.

There were complaints that several clubhouse renters had not received their deposits back within the 10-day time limit required for a refund. It is Alliant's responsibility to process the refund in a timely manner.

A resident complained that he had to use his "clicker" multiple times before the entrance gate would open. This has happened to several others, as well. The Vendor Oversight Committee chair had spoken with the gate vendor, and corrosion was found on the inside of the control. Since the gates are still opening slowly, the VOC chair will be asked to check into this some more.

As required, there was an organizational meeting of the board held immediately after the annual membership meeting adjourned. All the current officers were re-elected, and Jim Wisniewski was elected secretary to replace Jane Grethey.

Once again, I want to thank all committee and board members for all they do for Silverlakes.
